Objectives:

- 1. Eliminate Polythene Bags by implementing a nationwide ban on polythene bags through a multi-faceted approach.
- 2. Promote Sustainable Alternatives to Polythene Bags.
- 3. Eliminate Single-Use Plastic Sachets Through Policy Reform and Sustainable Alternatives.
- 4. Foster community involvement and ensure the effective monitoring of the implementation process.
